Back To The Future 75 YEARS & COUNTING

The history of American Insurance Agency really starts with the American Bank & Trust Company of Lewiston founded by A.L. Lyons, Sr. His son-in-law, O.M. Mackey, Sr. (married to his daughter Gertrude), also worked at the bank. O.M. Mackey along with George Thiessen and O.C. Carssow started a related company named the Mackey-Thiessen Investment Company, a corporation started in 1922. The operations of this company included real estate brokerage, real estate loans, and insurance. The insurance and loan operations grew to the point that on the 5th day of April, 1926 the name was changed to AMERICAN INSURANCE AND LOAN COMPANY (a name certainly influenced by the American Bank & Trust Company, as they operated side by side).

In 1927 Dr. O.C. Carssow built the Carssow building, a large two story white-brick structure with red tile valances for Spanish styling, on the corner of 9th & Main Streets in Lewiston. The building housed his doctors office, American Bank & Trust Co., the American Insurance & Loan Co., a drug store and other professionals.

Due to increased demands of the American Bank & Trust Co. for their time, the decision was made to sell the American Insurance & Loan Co. The business came to the attention of a hard working bank cashier/owner of the Bank of Starbuck in Starbuck, WA named Harry W. Christy. It was on August 15, 1928 that the business was sold to Harry W. Christy and his wife Blanche (Sullivan) Christy. American Insurance Agency has thus remained in the same location and my family to this present day. The American Bank & Trust Co. and the building was sold in 1955 to First Security Bank, the present owner.



HARRY W. CHRISTY, AGENCY PIONEER



Harry W. Christy was a remarkable and industrious man from his youth. He was born in Oklahoma, August 3rd, 1890 and served his country in World War I in an artillery unit. After the war he became a teacher and then a Superintendent of the consolidated school district in Stanwood (Cedar County), Iowa.

He married Blanche Sullivan in Bloomfield, Iowa. Harry was always working more than one job - coaching, selling athletic equipment to schools, and then some banking experience in Floris, Iowa.

The big guns of WW-I had limited his hearing which made teaching less fun, but helped his sales ability (it was said he just couldn't hear the word 'no'). So, with a wife and two children in tow, the Christys headed out west for a business opportunity to start his own bank in a then thriving, Starbuck, WA. Although successful, Harry still hadn't found what he wanted until he sold his small bank and moved to Lewiston to buy the American Insurance & Loan Co. on August 15, 1928.

Here Harry W. Christy staked his claim and built the insurance business and made personal and business loans. He was very acive in the community and spent over 50

years in the Boy Scout organization; State Commander of Disabled American Veterans and the American Legion. He was also Nez Perce Co. Chairman of the Civilian Defense from 1940 to 1946; and was discharged from the Idaho National Guard as an Army Colonel. He was an active member in the Chamber of Commerce, Elks Lodge, Methodist Church, and local Masonic bodies. Harry was also known for his large, impressive collections of rare coins and medals.

When he needed help to run his growing business Harry provided an opportunity to his wife's brother's son (his nephew by marriage). The young man who had just served and come back from W.W.II and was looking to start a career was Frank W. Sullivan. By the early 1960's the personal loan part of the business was discountinued and the name was changed to American Insurance

Agency. The insurance business was firmly built on service specializing in providing insurance value appraisals, complete coverage surveys and meeting all requests for insurance protection. Harry W. Christy led the firm as President for 27 years before retiring in 1955. He passed away in October 1969.

Frank W. Sullivan, born March 12, 1923, was one of fourteen children raised in Bloomfield, Iowa. Called "Bud" and "Buddy" by his family, Frank spent much

of his growing up years living and working on his grandparent's nearby farm. Upon graduation from High School he joined the Air Force to defend his country during W.W.II. While performing as communications officer on a B-17 flying over Germany, his plane was shot down and he was held as a prisoner of war. In the service he was nick named "Sully". A name that has stuck with him his entire adult life.

After being discharged from the military, Frank "Sully" Sullivan responded to the job opportunity offered by his Uncle Harry W. Christy out west in Idaho and joined the American Insurance & Loan Co., Inc. as an insurance agent on January 1, 1946. Sully excelled as an insurance agent and was a natural leader. As his policyholder accounts grew in number so did his involvement in the community. He served and was past president of: The Junior Chamber of Commerce (JC's), the Chamber of Commerce, the Lewiston Boys Club, the local and Idaho State Independent Insurance Agents Assoc., the Idaho

National Guard Assoc., The Community Chest (now United Way), The Lewiston Roundup Assoc., and the Lewiston Golf and Country Club. Sully is a lifetime member of: The Elk Lodge BPOE896, Masonic Lodge No. 10, Scottish Rite, York Rite, American Legion Post # 13, VFW, DAV, Reserve Offices Assoc., Purple Heart Club, and The 40 & 8. Other honors include recipient of the Young Man of the Year Award in 1954 for the State of Idaho, The Key Stone Medallion of the National Boys Club, Past Potentate of the Calam Temple of the Shrine, and Who's Who in the USA in 1966.

As a 1st Lieutenant in the Idaho National Guard he served 2 years in the Korean War Commanding Battery C-148th

Artillary and later retired from the reserves as a Lieutenant Colonel. In 1970, he purchased the remaining shares of American Insurance Agency from the Christy estate and continued to lead the agency until 1996 for a total of 50 years.

Did You Know 15 Years Ago...

- Street cars ran to 13th & Highland, Clarkston and East on G Street, Lewiston.
- New Lewiston Senior Hish School building had just been completed.
- New Interstate Bridge had not even been approved.
- The expression "OK" had not been heard.
- Mary, an elephant, had just made a dash down Main Street, resulting in broken windows, overturned cars and her death by the mayor.
- Not a single pleasure motorboat was in use on our rivers.
- The steamer "Lewiston" and barges were making regular trips to docks on Snake River Ave.
- Medical Payments on automobile insurance had not been instituted.
- Auto-Comprehensive Insurance, including glass breakage, was unknown.
- Extended Coverage (windstorm, smoke damage, explosion, etc.) had not been provided.
- The Homeowners Package Policy did not exist.
- Our telephone number was simply #84; changed to 3-4583 by 1950, to SH3-8528 by 1963, to 743-8528 by 1968, and 746-9646 in 1978.
