A PRISONER OF WAR. HIS B-17, THE SOUTHERN COMFORT WAS SHOT DOWN ON THEIR 15TH MISSION, ON A BOMB

RUN HIT BY GERMAN FLACK, THEY SKIDDED WHEELS-UP ON ITS BELLY IN TO A SWAMP IN HOLLAND. CAPTURED, HE SPENT 9 MONTHS IN A P.O.W. CAMP. FREED MAY 8TH 1945.

FRANK REMAINED IN THE MILITARY, ACTIVE IN THE IDAHO NATIONAL GUARD. ACTIVATED AS A FIRST LIEUTENANT, HE SERVED TWO YEARS IN THE KOREAN WAR IN A FIELD ARTILLERY UNIT.

ASIGNED AS THE OFFICER IN CHARGE OF FORWARD OBSERVERS FOR ARTILLERY MISSIONS. HE FELT HE NEEDED TO BE UP-FRONT WITH HIS MEN, IT WAS DURING ONE OF THOSE MISSIONS, HE WAS PINNED DOWN WITH A CHARGE OF RED CHINESE TROOPS FIREING, SCREAMING, BLOWING BUGLES, THEY OVERRAN HIS POSITION. PLAYING DEAD IN A DITCH, THEY WERE FINALLY PUSHED BACK.
